### **Grant Anderson joins Board of CMA**

Metal Recycling group CMA Corporation Limited (ASX: CMV) is pleased to announce the appointment of Grant Anderson as a Non Executive Director.

Mr Anderson has more than 25 years executive experience in the manufacturing and logistics industries, both in Australia and abroad.

Previous roles include CEO and President of PBR International, a leading supplier of brake system technology and subsidiary of ASX listed Pacifica Group Ltd. At the time, PBR International had revenues of \$A850 million and approximately 1,300 employees and operations in Australia, Asia, USA and Italy.

Mr Anderson also held a variety of positions at Britax International plc, a public company registered on the London Stock Exchange including Regional Managing Director (Asia) of the Vision Systems Division which included operations in Australia, India, China, Korea, Thailand and Japan.

“Given CMA’s plans for growth, we anticipate full utilisation of Grant’s skills and experience. His areas of expertise provide an excellent addition to the current Board and we are very happy to welcome him to CMA,” said Mr Good.

Mr Anderson is currently Chairman of AGSN Group a private family company which consults to the manufacturing and logistics sectors. He has been a Board Director in multiple countries from 1986 to 2007. He is Immediate Past President of the Federation of Automotive Parts Manufacturers (FAPM) Australia and is a Fellow of the Australian Institute of Company Directors.

His appointment to the CMA Board is effective from 1 October 2008.
